## **NSU Environmental Survey - Summary of Findings**

The survey conducted by the Campus Environment and Sustainability Task Force received 799 responses, an impressive result given the number of surveys available at NSU at the end of the academic year and the level of activity of faculty, staff and students at that time. Responses were encouraged by mass e-mails, listings on the NSU home page, in the *RiverHawk Daily*, and on John Vaughan Library home page, on kiosks at University Center during the week of Earth Day, and personal contacts by members of the Task Force. Although the largest number of respondents were students (question #1), our numbers represent a rather low percentage of students (4%), but significant percentages of faculty (54%) and staff (42%) at NSU.

The distribution of respondents by age, level of education, race and gender (#2-5) were close to what would be expected of the NSU community given the breakdown of respondents by faculty, staff or student.

We feel there are four main conclusions that can be drawn from the responses to the survey:

<u>1. Respondents had high concern for the environment</u>. Over half of the respondents have contributed to an environmental organization, signed a petition or attended a public meeting about an environmental issue (#6). When asked how concerned they were about various environmental problems, from 74-91% were "somewhat" or "very" concerned (#8-12). Overall, 94% felt efforts to protect the environment were "fairly" or "extremely" important (#33).

2. Respondents indicated a willingness to sacrifice or make lifestyle changes to achieve environmental improvement. From 74% to 88% of respondents either "somewhat" or "very strongly" believed that there should be more environmental controls and regulations (#13, 15). A majority of respondents believe more laws are called for to protect the environment (#14) and that the environment is more important than the economy (#16). A very high percentage of respondents take into account such issues as environmental impact and local origin when making a purchase (#29, 30) and make efforts to curb electricity and water consumption (#31).

<u>3. Respondents were concerned about global climate change.</u> Two-thirds believed America contributes "somewhat" or "a great deal" to global warming (#17) and 69% believe global warming is a problem requiring "some" or "immediate" action (#19). Nearly half felt they should take "moderate" or "significant" actions to curtail global warming (#18). A range of 64-81% of respondents were willing to learn more about global climate change and to take positive actions such as using less gasoline and electricity and to use more sustainable energy sources (#20). 82% of respondents have already chosen transportation options that help the environment (#21).

4. Respondents were overwhelmingly supportive of recycling, yet were frustrated by a lack of local recycling opportunities. A positive attitude regarding recycling was indicated by 89% of respondents (#22) but only 31% knew where the recycling facility was in Tahlequah (#27). (We admit to writing a poor question on #27, as the survey went out to people on all three campuses. We were justifiably criticized for this in the comments.) An overwhelming 97% of respondents said they would recycle on the NSU campus (#26) but only 20% were aware of any opportunities to do so (#28). Despite the fact that 70% were frustrated by poor access to recycling facilities (#25) 63% of respondents did report that they recycle

(#23) and a large majority chose to do so because of positive reasons rather than out of a sense of obligation or financial incentive (#24).

As for actions NSU should take the largest number (87%) felt recycling efforts should be improved, 81% thought NSU should have an environmental policy and 72% would read an "Environmental Tip of the Day" on the home page of the NSU web site (#32).

In general the survey results support the short term and long term recommendations of the Campus Environment and Sustainability Task Force. We hope this survey is helpful in guiding NSU in making choices about its commitment to a more sustainable future.

## Comments

- 1. Overall I agree that treating the environment in a friendly manner is important. I do not agree with such things as carbon credits because invaribly it is just another way for someone to take money and does not reduce overall emmissions.
- 2. What about a carpooling program.
- 3. By American standards my carbon footprint is very low but by world standards it is still high.
- 4. MOST IMPORTANT: we need local facilities to recylce plastics and paper! On campus would be best!
