#### TEACHER EDUCATION FACULTY DESIGNATION

The following faculty are considered Teacher Education Faculty:

- Full-time faculty members in the College of Education who teach courses in majors / programs that
  prepare teachers or other school personnel (administrators, library media specialists, reading
  specialists, school counselors) or those who teach courses within the professional education core are
  designated as teacher education faculty (TE FAC). COE faculty who teach in masters programs
  designed for the continuing preparation of teachers (M.Ed. Early Childhood, M.Ed. Teacher, etc.) are
  also considered teacher education faculty.
- For those full-time faculty members in the College of Education who teach courses taken by both teacher education and non-teacher education majors (H & K and/or PSY), then the determination is made on a yearly basis. If 50% or more of the load assignment involves teacher education course work, then the person is considered TE FAC for that academic year. These courses include

• Program coordinators / program chairs who oversee teacher education programs, no matter their college of origin, are considered teacher education faculty.

## **Teacher Education Faculty Development Plan**

At NSU, all teacher education faculty must show evidence of professional development annually. They must develop a plan which is reviewed by the professional development committee. Once approved, the plan is returned to the faculty member who then documents completion of the proposed activities at the end of the academic year.

#### **Public School Service**

State regulations require that teacher education faculty serve a minimum of ten (10) hours in a public school annually. These hours should be activities beyond those assigned as part of the faculty member's regular load. This service may be met in a variety of ways and can include serving on a Residency Committees above load (1 committee=2 hours; 2 committees = 4 hours). When counting as public school service, the faculty member accepts no pay or stipend for residency committees. No more than four hours of the ten hour requirement may come from residency committees.

## **Oklahoma State Regents for Higher Education**

OSRHE requirements for teacher education faculty are grounded in the recommendation of the External Program Review committee that operated from 1992-1995. The committee's recommendation was as follows:

#### Recommendation 15

Increase the requirement that teacher education faculty members teach in public schools a minimum of 10 hours per year to keep faculty attuned to and cognizant of the reality of today's classrooms and schools.

## **Oklahoma Commission for Teacher Preparation**

OCTP state standards and requirements for joint NCATE/State team site visits include the following:

# 9. Faculty Professional Development

- Units have an active system in place documenting and reporting the annual professional development activities of all teacher education faculty members.
- All full-time teacher education faculty members directly involved in the teacher education process, including all administrators of teacher education programs, are required to serve in a state accredited public school for at least ten (10) clock hours per school year in direct contact with meaningful and relevant responsibilities related to their respective teacher education fields.
