Please be aware that if you drop a course, withdraw, or never begin attendance in all courses for which you are registered you may be required to repay all or a portion of the financial aid you received. **ALL** Summer loans will be disbursed in two equal disbursements, the first half in June, the second half in July; in addition, any first time loan borrowers will have a 30-day delay in the disbursement of their student loans.
