Statement of Understanding

I understand that I must satisfy the following requirements as outlined in the Graduate Catalog in order to pursue a master's degree in Social Work (MSW):

## CONDITIONAL ADMISSION

You are being granted conditional admission to the MSW based on GPA requirements, and are subject to the following stipulations:

- 1. A graduate program GPA of 3.25 must be maintained for nine (9) credit hours of MSW course work taken at Northeastern State University;
- 2. Full admission will be considered by the MSW Admission Committee at the completion of 9 credit hours or successful completion of the first semester if the student is enrolled in more than 9 credit hours; and
- 3. The second semester of enrollment must be authorized by the director of the MSW program.

## **OTHER REQUIREMENTS:**

- 1. Students must complete SOWK 5903 Integrative Capstone Seminar.
- 2. Students may earn no more than **12** hours for summer semesters and **16** hours for each fall and spring semesters. Prior approval from the Program Chair is required for any overload.
- 3. Students may transfer a maximum of 9 semester hours from other accredited universities with approval of the program Director provided each transfer course has a grade of "B" or better.
- 4. No coursework used for graduation may be older than 6 calendar years excluding time spent in the Armed Forces.
- 5. After meeting the GPA requirement for full admission to the MSW as stated above, students must maintain a grade point average of 3.00 in all graduate coursework attempted. No grade less than a "C" may be used for graduation. I agree to abide by the regulations governing the graduate program as stated in the Graduate Catalog.
- 6. Students utilizing federal financial aid must be enrolled in at least half-time status for eligibility. Half time status is defined as 5-8 graduate level credit hours, and full-time status is defined as 9 or more. Financial aid will only be awarded for courses in the student's plan of study.
- 7. Students choosing not to maintain continuous enrollment must notify the program Director of their intent to withdraw from the program in order to remain eligible to re-enroll in the MSW. Students must meet the catalog requirements and expected curriculum for the academic term in which they return.
